



PRIVACY POLICY

Purpose and Scope of this Privacy Policy and Definitions

CavaWoman (defined above) follows all legal requirements to protect your privacy. This Privacy policy is a legal statement that explains how we may collect information from you, how we may share your information, and how you can limit our sharing of your information.

“Non-Personal Information” is information that is not personally identifiable to you and that we automatically collect when you access CavaWoman Site (defined above) with a web or mobile browser. It may also include publicly available information that is shared between you and others.

“Personally Identifiable Information” is non-public information that is personally identifiable to you and obtained in order for us to provide you within CavaWoman Site. Personally Identifiable Information may include information such as your name, email address, and other related information that you provide us or that we obtain about you.

1. By submitting your Personally Identifiable Information through CavaWoman Site, you agree to the terms of this privacy policy and you expressly consent to the collection, use and disclosure of your Personally Identifiable Information in accordance with this Privacy Policy.
2. This Privacy Policy does not apply to information collected about you by anyone except CavaWoman and only applies to the CavaWoman site.

How We Collect Information

1. **Information You Provide.** CavaWoman generally collects Personally Identifiable Information that you voluntarily provide. For instance, when you create an account or register, participate in any of our social networking features, subscribe to receive newsletters or other electronic services, or send us an email or feedback, you may be



asked to provide information such as your email address, name, phone or mobile number, address, and we will collect such information as well as any other content you provide us in engaging in any of the above activities.

2. **Information we collect automatically.** When you use CavaWoman site, we automatically collect certain computer information by the interaction of your mobile phone or web browser. Such information is typically considered Non-Personal Information.

We also collect the following:

- **Cookies**
 1. A Cookie is a small piece of data (often including a unique identifier) that is stored on your computer or mobile device by your web browser when you visit a website. We use Cookies to understand site usage and improve the content and offerings on CavaWoman site. Most web browsers can be set to disable the use of Cookies. However, if you disable Cookies, you may not be able to access full functionality of CavaWoman correctly or at all. We never place Personally Identifiable Information on Cookies.
- **IP Address.** Your Internet Protocol (“IP”) address is usually associated with the place from which you enter the Internet, like your Internet Service Provider, your company or your university.

How We Use Your Information

We use the information we receive from you as follows:

1. **Customizing and Improving Our Website.** We use your information that may include Personally Identifiable Information to identify you as a user, improve CavaWoman site and services, send you administrative notifications, and respond to your inquiries.



2. **Marketing Purposes.** We may combine and use any and all information we collect on you either online or otherwise, including from third parties, for the purpose of marketing. We may create Anonymous Information from Personally Identifiable Information by excluding information (such as your name) that make the data personally identifiable to you. We use this Anonymous Information for any purpose and disclose Anonymous Information to third parties in our sole discretion.
1. **Social Networks.** If you use your login credentials from a social networking site (e.g. Facebook or Twitter) (collectively, “SNS”) on a CavaWoman Site, we may receive information from such SNS in accordance with the terms and conditions (e.g., terms of use and privacy policy) of the SNS (“SNS Terms”). If you elect to share your information with these SNS, we will share information with them in accordance with your election. The SNS Terms of the SNS will apply to the information we disclose to them.
2. **Delivery of Advertising and Other Content.** In addition to ads and content that we serve you directly, we use third party advertising companies and marketing services companies to serve ads and other content when you visit a CavaWoman Site. Both we and these companies may use information about your visits to this site and elsewhere to serve ads and other content to you. In the course of doing so, a unique third-party Cookie may be placed or recognized on your browser by such companies.

Right to Opt-out

1. **Email Policy.** We and our affiliates and partners fully comply with national laws regarding SPAM. If you wish to opt out our email services, you may do so by following the unsubscribe instructions in the email you received. We agree that we will not sell, rent, or trade your email address to any unaffiliated third-party partners without your permission.
2. **User Registration.** You may elect to change the details of your user registration at any time by logging in and editing your User Profile. If you wish to cancel or delete your User Registration, you may contact us at nadya@cavawoman.com Please take note that



when we delete any information, it will be deleted from the active database, but may retain in our archives. We may retain your information for fraud or similar purposes.

Security of your Personally Identifiable Information

We use a variety of industry-standard security technologies and procedures to help protect your Personally Identifiable Information from unauthorized access, use, or disclosure. We also require you to enter a password to access your registration information. Please do not disclose your registration password to other people. No method of transmission over the Internet, or method of electronic storage, is 100% secure, however. Therefore, while CavaWoman site uses reasonable efforts to protect your Personally Identifiable Information, CavaWoman cannot guarantee its absolute security.

Child and Parents

CavaWoman site is not designed for use by anyone under age 13("Child"). If you're a Child, please seek the permission of your Parent or Guardian before using our website. If you are a Parent or Guardian and believe that your Child is using our website, please contact us at nadya@cavawoman.com to request deletion of any information provided by your Child and indicate in the subject line "Deletion Request for Minor". We reserve the right to ask you for verification of your relationship to the Child before we honor such a request. If we discover that a Child has created an account on our website, we will immediately delete the account as soon as possible. We will not use the information for any purpose, and we will not disclose the information to third parties. However, as a Parent or Guardian of such a Child, you understand that you are legally liable for any transactions created by the Child. There are commercially available tools to help you limit your Child's exposure to materials online. If your Child posted comments on CavaWoman site, you may also request for us to delete this comments, by providing us with the website live URL address where the content resides, a copy of the content (cut and pasted into your email), and the date of publication and, if applicable, the user name associated with it. We will act as promptly as possible to remove any information



(except in certain circumstances mandated by law). Note that our deletion does not ensure complete or comprehensive removal of your content from the internet and comments that may have been posted by others about you and your Child or your posting will remain accessible online.

Non-Philippine Residents

If you are located outside the Philippines, please note that the information you provide to us will be transferred to and processed in the Philippines, where laws regarding processing of Personally Identifiable Information may be less or more stringent than the laws in your country. By using this website, you consent to this transfer and processing. You also consent to the adjudication of any disputes arising in connection with this website in the accordance with the laws of the Philippines.

Privacy Policy Updates

We reserve the right to modify this privacy policy anytime. If we make any material changes in the way we use your Personally Identifiable Information, we may notify you of the changes on our website, by email, or by any method we determine. The method we chose is our sole discretion. Any changes to this privacy policy will be effective upon Fifteen (15) days following our posting of notice of the changes on our website and will replace any prior Privacy Policies. These changes will be effective immediately for new users of our website. Continued use of our website, following notice of such changes shall indicate your acknowledgement and agreement to be bound by the terms and conditions of such changes.
